Third semester college-level Spanish. Further improve conversation and comprehension proficiency. Develop reading and writing skills through literary analysis and grammar review. This class is designed to further develop and strengthen the language skills acquired in Spanish II.

METHODOLOGY

- Tell an anecdote
- Express wishes
- Express needs and requests
- Express impersonal actions
- Stake claims
- Qualify a situation (positively or negatively)
- Talk about habits
- Express suggestions
